Law firm's new name reflects partnership

One of the area's most recognized law firms amended its name recently to reflect the fact that attorneys Danny Glover Jr. and Keith Teague are partners.

Although the shingle still needs to be changed, the law firm of D. Keith Teague P.A. is now known as Teague and Glover P.A.

Teague will continue to work in the courtroom on criminal defense, DWI and traffic cases. And Glover will continue to handle the serious bodily injury and accidental death cases, as well as civil litigation and appeals to the North Carolina Court of Appeals and N.C. Supreme Court, Glover said.

The firm, which recently celebrated its 25th anniversary, has a staff of six assistants. Three of the staff members have worked at the firm for over 15 years and two have been there for more than 22 years, Glover said.

"We are extremely proud of our experienced, compassionate and loyal staff and the work that they do in helping the people that we serve on a daily basis," Glover said.

Glover said Friday the name change at Teague and Glover simply reflects the update at the law firm. Glover became a partner in the firm in 2003.

Teague graduated from Wake Forest School of Law and moved to Elizabeth City in 1973, where he joined the District Attorney's office. He worked as a prosecutor in the 1st Judicial District for eight years. In 1981, Teague opened the law firm of D. Keith Teague P.A.

Teague is a member of the N.C. Academy of Trial Lawyers, N.C. State Bar, N.C. Bar Association, Association of Trial Lawyers of America and the American Board of Trial Advocates.

Glover graduated from the University North Carolina at Chapel Hill School of Law and moved to Elizabeth City in 1995. For the last 11 years he has focused on serious bodily injury and accidental death cases, as well as general criminal and civil litigation and appeals.

He is the chairman of the Automobile Torts Section of the N.C. Academy of Trial Lawyers and also serves on the Academy's Board of Governors and PAC Board.

"I am pleased that Danny has been a partner in my firm," Teague said. "For eleven years we have worked as a team, and I look forward to that continued teamwork for a long time. We also want to thank the people of the Albemarle region for trusting us with their legal needs for the past 25 years."
